1. INTRODUCTION

5. STRUCTURE OF 4-YEAR DEGREE (B.TECH) PROGRAMS

The Institute is aimed to offer education in emerging areas of Engineering and Technology through Diploma, Degree and Higher modules. This Brochure provides information of counseling for admission to the Degree (B. Tech) Programs offered by this Institute under the Maulana Abul Kalam Azad University of Technology (MAKAUT), West Bengal in the session of 2018-19.

B. Tech (4 Years Duration)	<p>As per Government decision, 50% of total seats of GKCIET are reserved for the candidates of West Bengal on merit and rest 50% will be filled on all India basis. Of the seats to be filled on all India basis, half (25%) will be filled from the candidates belonging to North-East (NE) states on merit and rest (25%) will be filled on all India basis on merit. Followings are the admission criteria for these quotas:</p> <ul style="list-style-type: none">• 50% of the approved intake shall be filled up through West Bengal Joint Entrance Examination (WBJEE) Board for the candidates of West Bengal.• 25% of the approved intake shall be filled up from the eligible candidates having valid score/rank in Joint Entrance Examination (Main) – 2018 conducted by CBSE; from the 8 states of North-East (NE), i.e., Meghalaya, Assam, Arunachal Pradesh, Mizoram, Tripura, Manipur, Nagaland and Sikkim.• 25% of the approved intake shall be filled up from the eligible candidates having valid score/rank in Joint Entrance Examination (Main) – 2018 conducted by CBSE; from other states excluding West Bengal and NE states.

6. FEES STRUCTURE FOR THE ACADEMIC YEAR 2018-2019

The fees structure of the 4-year degree programs for the academic session of 2018-2019 is available on the website of the Institute. **Hostel accommodation is not available at present.** However, the hostel facility at permanent campus of the Institute at Narayanpur, Malda shall be available after construction in due course of time.



7. ELIGIBILITY CRITERIA FOR ADMISSION TO THE B. TECH PROGRAMS OF GKCIET, MALDA

- (i) Candidate must be a citizen of India.
- (ii) Candidate must have valid score/rank in JEE (Main) - 2018. They must produce their score card/rank card of JEE (Main) – 2018 during counseling.
- (iii) Passed **10+2** examination with **Physics** and **Mathematics** as compulsory subjects along with one of the **Chemistry/Biotechnology/Biology/Technical Vocational subject**. Obtained at least 45% marks (40% in case of candidates belonging to reserved category) in the above subjects taken together.
- (iv) The age limits as per JEE (Main)-2018 criteria.

9. PRINCIPLES OF ADMISSION

Admission to all Degree programs shall be made for the candidates qualified in the **JEE (Main)-2018** on the basis of **merit of JEE (Main) score/rank among the candidates appeared in counseling process.**

In principle relating to the reservations, the Institute will follow the reservation policies as per the MHRD/Govt. of India. Subsequently, a seat reservation for the reserved categories will be followed as per the latest guidelines issued by the Government of India from time to time. **Any candidate**



claims a seat under reservation quota must submit the copy of relevant certificate(s) issued by the competent authority along with the Application Form; else s/he will be treated as a general candidate.

10. TERRITORIAL QUOTA

Total seats meant for the Degree programs are bifurcated for the candidates of West Bengal and other States, respectively in the following proportion:

Quota for West Bengal: 50%

Quota for other states: (50%)

For the states of North- East (NE): 25%

For other states (excluding WB & NE): 25%

11. APPLICATION PROCEDURE

Application Form for admission to B. Tech programs of GKCIET, Malda will be available in the Institute website: <http://www.gkciet.ac.in> from 18th June, 2018 onwards.

HOW TO APPLY & ATTEND COUNSELING :

- (i) Prepare a Demand Draft of **Rs 12, 600/- (Twelve Thousand Six Hundred Only)** as 1st Semester Fees in favour of “**Accounts Officer, GKCIET, Malda**” payable at **Malda**.
- (ii) Go to the website of GKCIET at <http://www.gkciet.ac.in> and download the Application Form available in .doc & .pdf formats.
- (iii) Take printout and fill up the form.
- (iv) Paste photograph and put signature(s) in the appropriate places in the form.
- (v) Attend and submit a copy of Rank/Score Card of JEE (Main)-2018 on **11th July, 2018 from 08:00AM to 11:00AM**.
- (vi) Soon after, the candidates shall be called for counseling based on the score/rank of JEE (Main)-2018 among the candidates reported **from 08:00AM to 11:00AM of 11th July, 2018**. While appearing before the Counseling Committee, candidate must submit hard copy of the duly filled-in **Application Form** along with the **Demand Draft (original)**, Rank/Score Card of JEE (Main) - 2018 and copy of necessary documents (duly attested).
- (vii) Counseling shall be conducted until all the seats are filled as per the **Seat Matrix** on **11th July, 2018 upto 06.00 PM**. In case any seats are vacant at the end of the counseling on **11th July, 2018** or counseling process for all the candidates reported is incomplete, it would be continued from **10.00 AM onwards on 12th July, 2018**.
