The Institute is autonomous in character and is registered under the Societies Registration Act. The Institute is fully funded by the Central Government. The appointment shall be made on contract basis for an initial term of 5 years or till the age of 65 years whichever is earlier.

**Eligibility criteria for the candidates:-**

**(a) Qualifications**

Ph.D (with first class degree at Bachelor's and Master's level). In addition, the candidate should be an eminent person in his/her field of specialization.

**(b) Experience**
