- The candidate should be a citizen of India. i)
- ii) All candidates are required to apply online in the prescribed format with complete, correct information and attachments. The candidate will be solely responsible for

the authenticity of the submitted information. Candidates are required to fill the online application form as available on the Institute website www.gkciet.ac.in. The details regarding qualifications, experience, screening guidelines and indicative proformas etc. are available on the Institute website www.gkciet.ac.in, along with this advertisement. The candidates are required to read these details carefully before filling up the form.

- iii) The post of Junior Engineer and Junior Assistant shall be filled through written test and skill test as per modalities fixed by the institute.
- iv) Application Form must also be accompanied by self-attested copies of Educational and Professional Qualifications, Experience, Caste Certificate/ PwD Certificate, as the case may be, (in case claiming benefit of reservation).
- v) Applicants seeking reservation benefit available for SC/OBC/PwD category must upload the necessary documents justifying the claim of respective reservation as per Govt. of India norms. The certificate uploaded should be in the format prescribed by the Govt. of India.
- vi) In case the candidate wants to claim benefits under the PwD category, the candidate's relevant disability should not be less than 40 per cent. Proof to this effect in the form of a valid Disability Certificate must be uploaded with the application.
- vii) The appointment will be made on regular basis subject to initial probation period of duration two years as per CCS rules and approved Recruitment Rules of the institute.
- viii) The appointment will be subject to the candidate being medically fit.
- ix) At present the age of retirement for non-teaching staff positions is 60 years.
- X) Residential accommodation on campus may be provided subject to availability; otherwise the employees are entitled for house rent allowance.
- xi) The appointees will be governed by new pension scheme as applicable to the employees of the Institute as per Government of India norms.
- Xii) The appointees are entitled for the benefit of Leave Travel Concession as per applicable rules.

- e. Please attach a self-attested copy of your Birth Certificate/Matric/Secondary School Certificate as evidence of your date of birth.
- f. Self-attested copies of certificates
 - Educational qualifications: Matriculation onwards
 - Experience: Teaching, Research, Industry, any other from employer from latest to the earliest.
 - Proof for SC/ST/OBC/PWD (Differently abled persons) i.e. Certificate issued by competent authority (as per Govt. of India guidelines).

g. Cut-off date for determining age limit and experience will be the last date for receipt of the online applications (10th February 2025).
